Minutes of the meeting of Lower Halstow Parish Council held on Tuesday 3 July 2018 following the Annual Council Meeting in the Memorial Hall, Lower Halstow.

Present: Cllr Rob Smith (Chair); Cllr Keith Howard-Challis (Vice-Chair); Cllr Allyson Beerstecher; Cllr Steve Gates; Cllr Rod Dadson; Cllr Ben Stokes; Cllr Dewar-Whalley and 4 members of the public were in attendance.

1. Apologies

Apologies were received from: Cllrs Parker and Whiting.

2. <u>Declarations of Interest</u>

a) Disclosable Pecuniary Interests

None

b) <u>Disclosable Non-Pecuniary Interests</u>

Cllr Gates declared a non-pecuniary interest in item 6e.

3. Public Session

A resident has contacted KCC in respect of the grass verges in The Street to find try and find out when they will be cut. There is supposed to be five cuts a year with the first cut in July but it has been left for far too long and it is a mess giving an overall bad impression of Lower Halstow.

Another resident commented about parking on the pavement and grass verges.

A resident asked if there had been any consultation from Swale Borough Council regarding the naming of the new development in School Lane.

There were complaints about the verge cutting in Wardwell Lane, Boxted Lane, Breach Lane and The Street. It had been done very erratically; some bits were cut very close taking out hedges, including the roots and soil, in other places were missed altogether. Damage had occurred to residents' property.

4. Visitors reports or comments

- a) SBC Councillor Ben Stokes gave an update on the problems at the culvert by the Three Tuns and will try to arrange a site meeting with KCC councillors and Peel Ports. SBC Councillor Dewar-Whalley reported that he has agreed grant funding towards the laptop for the use of the Clerk and for the WW1 Battles's Over events.
- b) Report from PCSO John Cork:

Theft of motor vehicle. Knife found by resident and booked into property for destruction. Brickfields and surrounding area patrol in the evening no problems to report.

c) KCC report from Cllr Mike Whiting:

It has been a very quiet month, which in many ways is a good thing!

I have met with residents in Breach Lane regarding vehicle priority for traffic between the A2 and the village in the narrowest sections of the road. I am working with Highways engineers at KCC to see what may be done to improve things.

KCC is currently consulting on its Public Rights of Way improvement plan and documents can be found at www.kent.gov.uk/rightsofwayimprovementplan. The consultation is open until 12 September.

KCC is also holding two meeting regarding subsidised bus services. The Big conversation meeting will be held at UK Paper, Avenue of Remembrance in Sittingbourne at 7pm on 18 July. Consultation documents are also available on line at

www.kent.gov.uk/bigcoversation or in hard copy from FREEPOST BIG CONVERSATION. This is about how we can maintain or improve local rural bus services such as the 326/7 and I would urge everyone to get involved. The Parish Council will also be invited to a Parish Meeting in Maidstone, organised through KALC.

d) Cutting of Verges

The verges are in a bad state and Cllr Gates proposed that the Parish Council instruct KCC to forget about the daffodils planted so that the verges are cut regardless, seconded by Cllr Howard-Challis. All were in favour. Cllr Gates also reported to the meeting damage caused by erratic verge cutting and that enforcement is required in respect of parking on the grass verges and fly tipping.

Cllr Gates requested that the draft Minutes are produced in a timely fashion.

a) Brickfields

Cllr Beerstecher, seconded by Cllr Howard-Challis, proposed that the Friends of Lower Halstow Brickfields Constitution be signed. All were in favour and it was duly signed. Cllr Smith gave thanks to everyone involved.

There is a badly damaged tree at the entrance to the Memorial Wood. A quote will be sought to remove the branch.

It was noted that bottle diggers have started again.

Cllr Gates will present a draft of the Open Spaces Policy at a future meeting.

b) Parks and Leisure

A quote will be sought for the installation of a park bench at the recreation ground.

c) Docks and Barges

The damaged area at the dock will be fenced off in the next few weeks. A quote for a specification for repairs will be sent to the Parish Council shortly. Other quotes are also being requested.

d) Burial Ground and Allotments

The "leaky" pipe at the burial ground has been stolen. The chain link fence along the grassed area opposite the Three Tuns needs replacing.

e) Footpaths Highways and Lighting

An overgrown hedge is consuming the streetlight in the turning circle in Crouch Hill Court. A letter will be sent to the landowner to request that it is cut back.

It has been reported that there is CCTV footage in respect of the streetlight that has gone missing in Burntwick Drive. This will be followed up.

Cllr Smith reported that there was a very good speaker on the subject of 20 mph speed limits. A new secretary had been elected.

12. Clerks Report:

The Clerk has £100 to pay in for car park rents and £5.00 for a brickfield combination code. One car park space is being offered to the next resident on the waiting list.

The Finance work party met on Thursday 28th June. It was discussed that the cost of the street lighting could be met by allowing for it in next two years precept. Forward planning for the dock repairs would be required and councillors are requested to consider the Edith May mooring fees for discussion at the September meeting.
